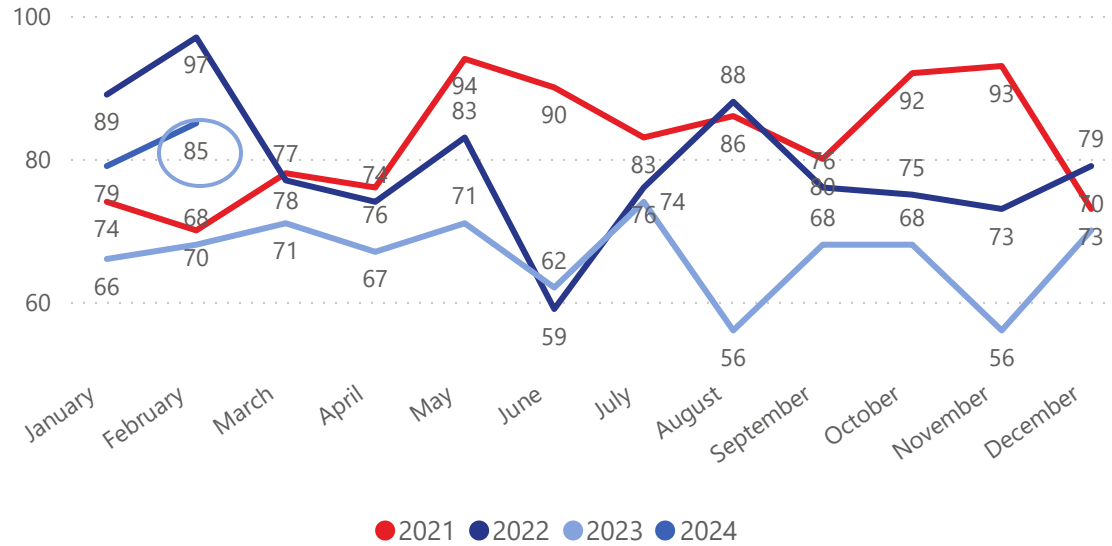


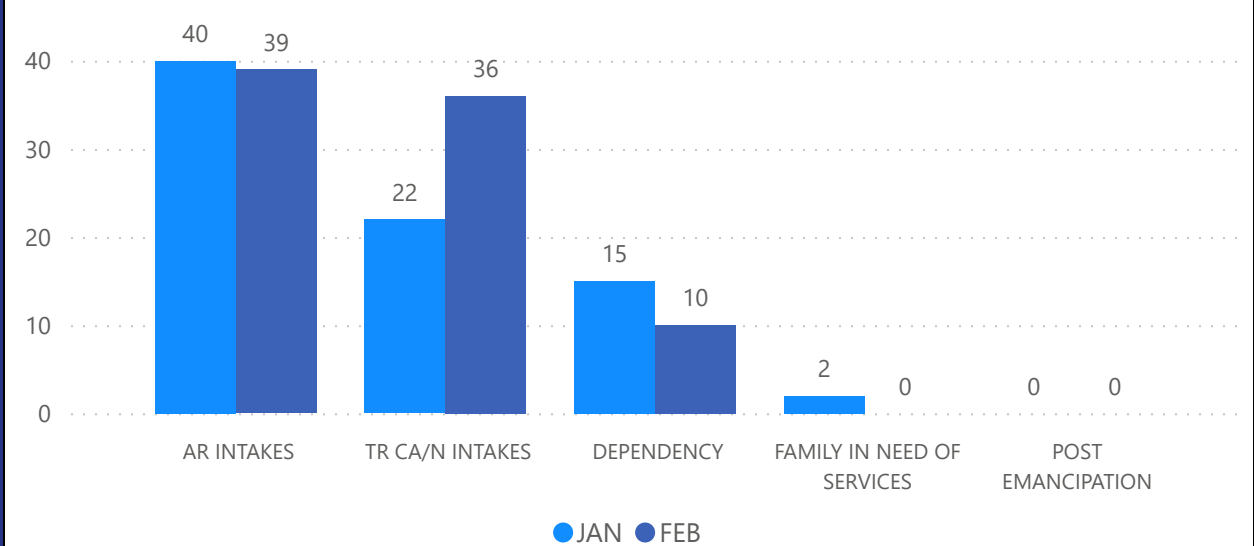

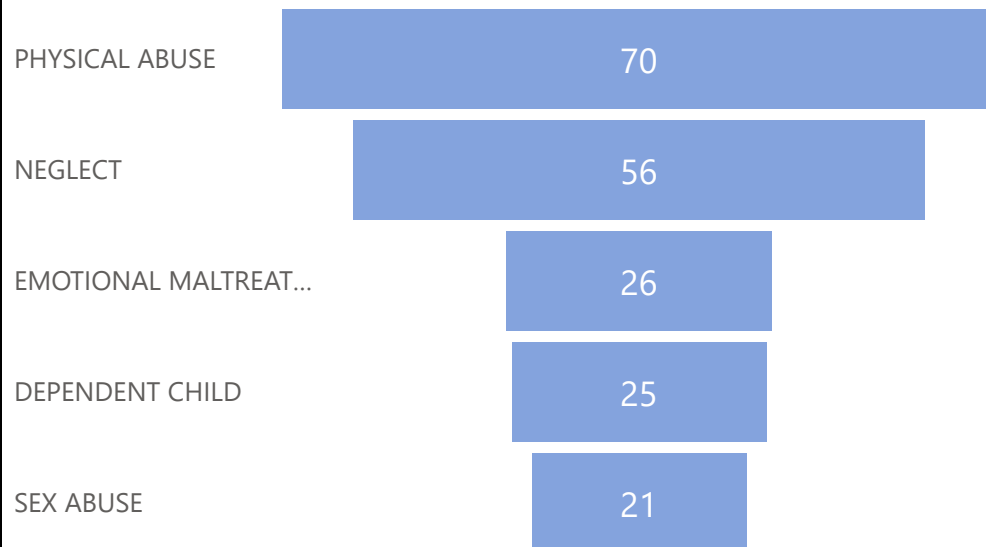
### TOTAL INTAKES



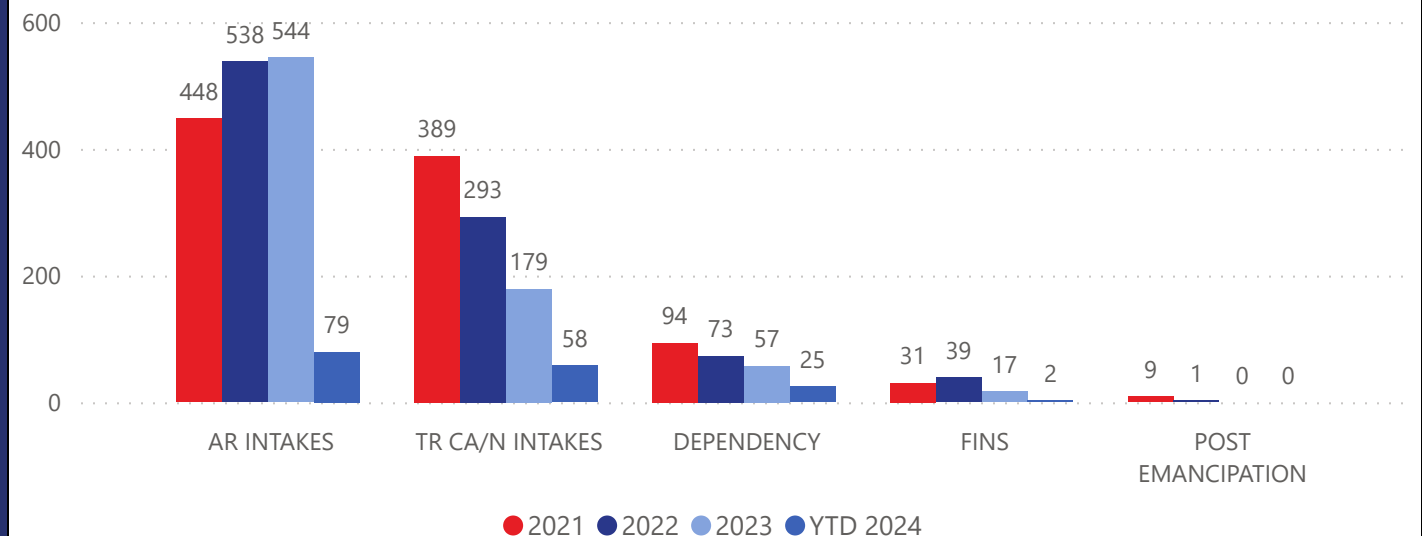
### INTAKE TYPES - JAN - FEB 2024



### TOP 5 PRESENTING PROBLEMS - JAN - FEB 2024



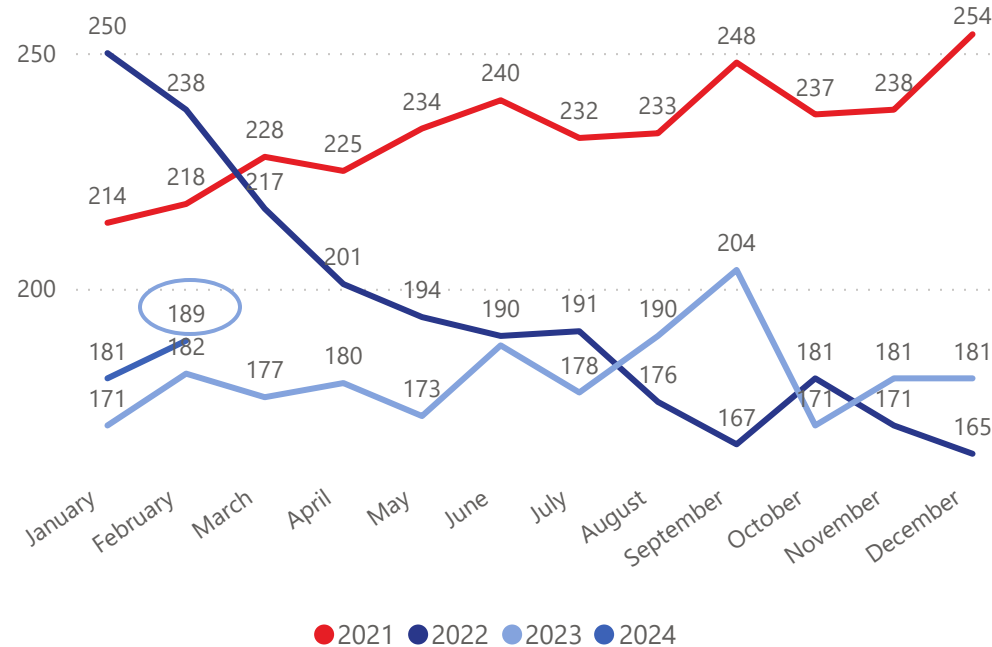
### INTAKE TYPES - YEAR COMPARISON



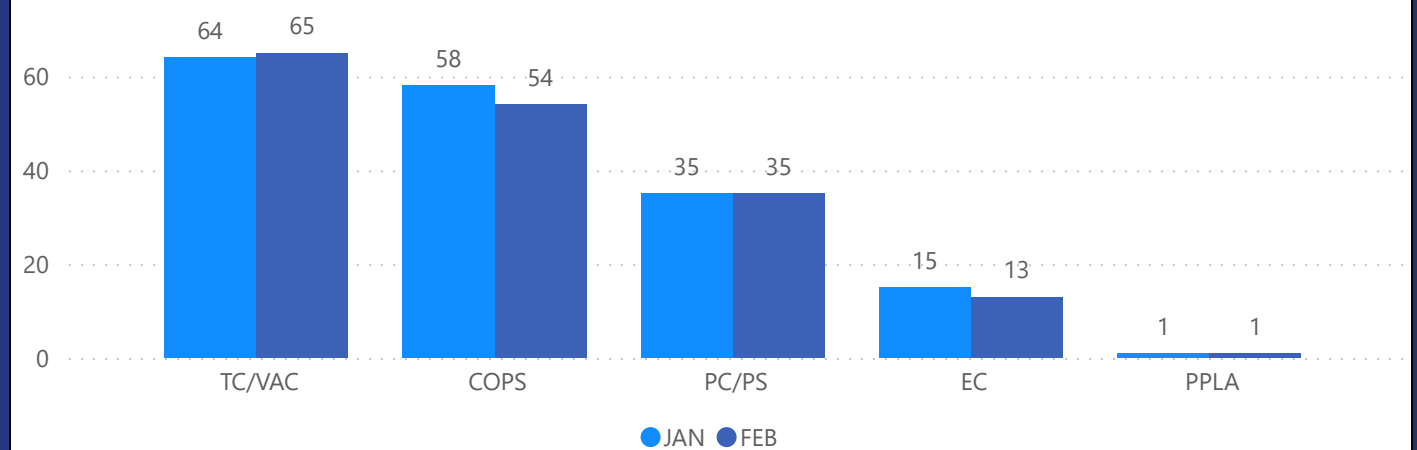

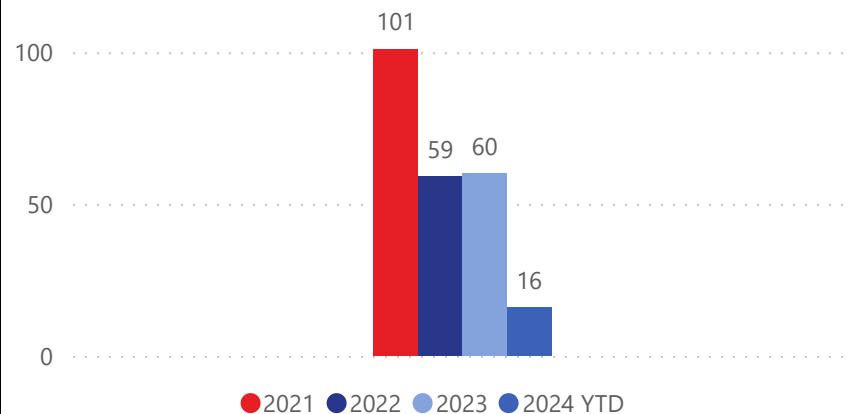

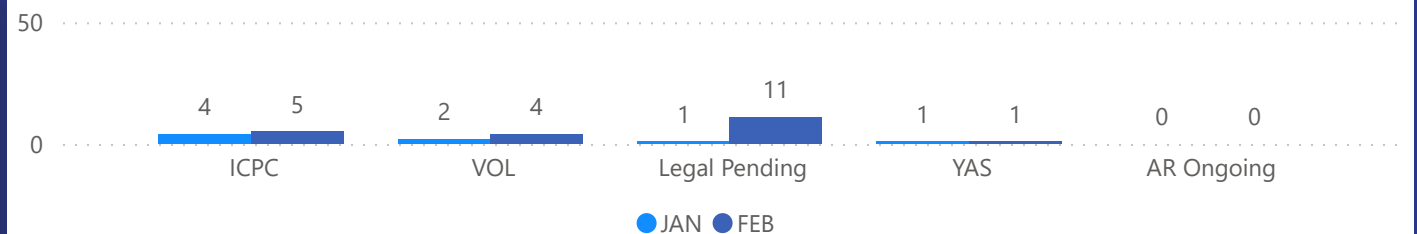

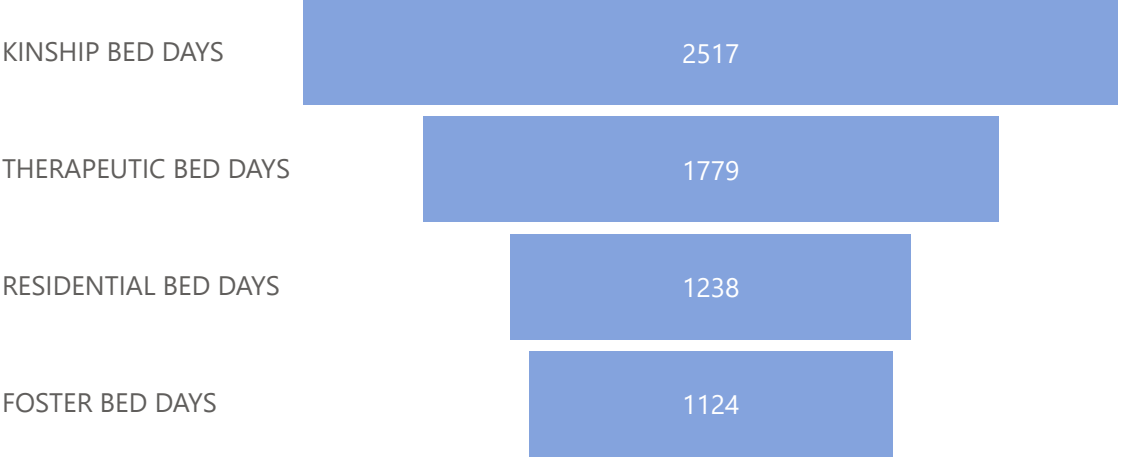

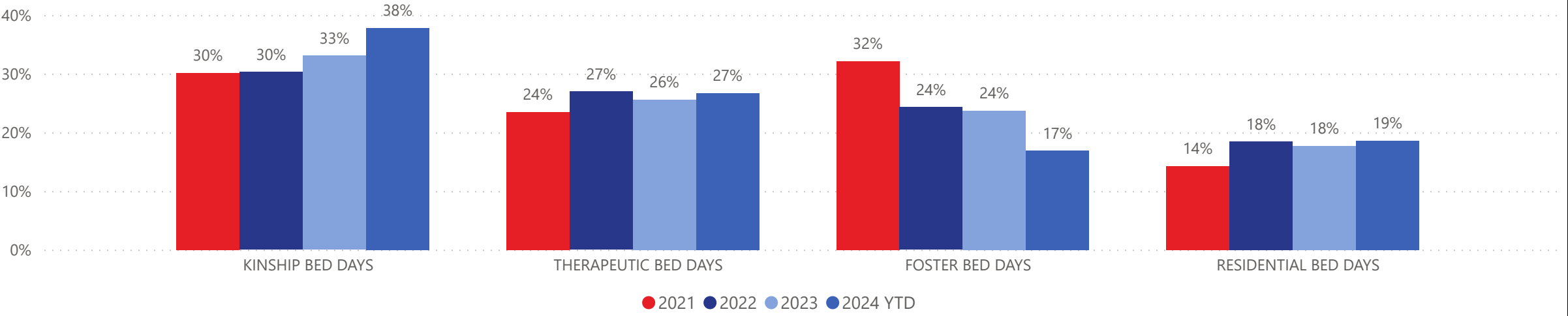

## BED DAYS - PERCENTAGE OF TOTAL





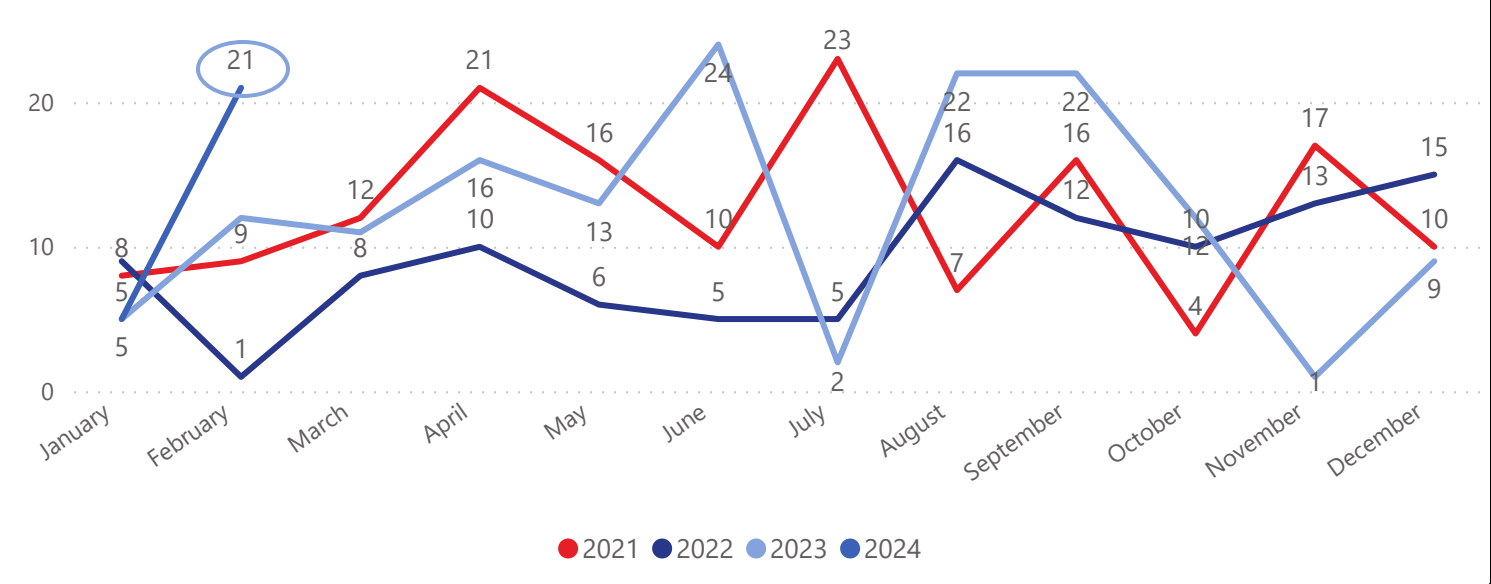

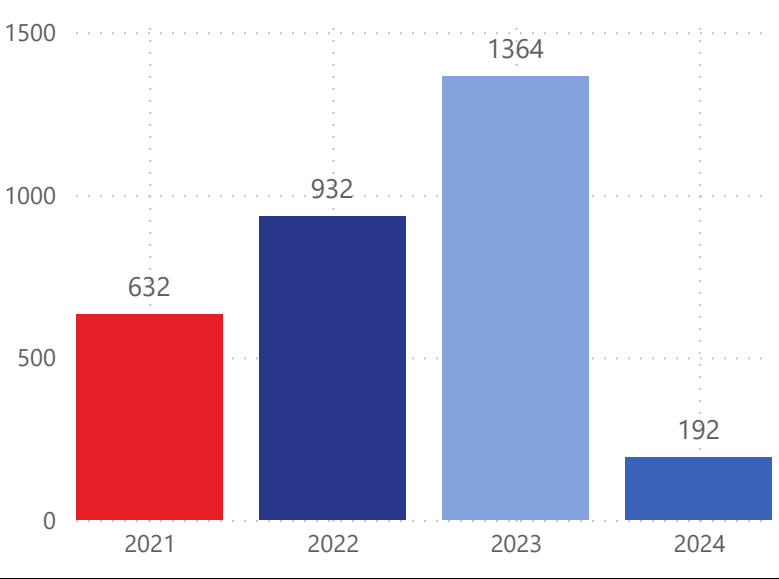
